For the quarter ended March 31, 2018, the Company's net revenue stood at Rs.521.08 crore as against Rs.609.81 crore of Q4 of the previous year. The Operational EBIDTA for the period stood at Rs.8.84 crore as compared to Rs.9.86 crore in the corresponding quarter in the previous year. The net loss for the quarter ended March 31, 2018 is Rs.30.29 crore as compare to Rs.14.83 crore in the corresponding quarter in the previous year.

For the financial year ended March 31, 2018 the net revenue stood at Rs.2,317.44 crore as compared to Rs.2,729.57 crore in the previous year. The Operational EBIDTA is Rs.60.22 crore as compared to Rs.23.76 crore in the last fiscal year. The net loss of the Company is Rs.82.69 crore for the current financial year as against Net Loss of Rs.84.03 crore during the last financial year.
