CODE OF CONDUCT FOR BOARD MEMBERS & SENIOR MANAGEMENT PERSONNEL

[Pursuant to Regulation 17(5) (a) of Chapter IV of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015]

PREMBLE

This Code of Conduct ("the Code") shall be called "Revised Code of Conduct for Board of Directors, Key Managerial Personnel (KMP) and Senior Management of Indo Rama Synthetics (India) Limited" (hereinafter referred to as "the Company").

The term "Senior Management" shall mean personnel of the Company, who are members of its core management team excluding the Board of Directors. Normally, this would comprise of all members of management one level below the Executive Directors, including all functional heads.

OBJECTIVE

With a view to maintain high standards of governance, to induce and recognize the virtues of honesty and accountability and to serve as a guideline for addressing situations involving ethical issues in all spheres of activities of the organization, the following Rules/Code of Conduct is required to be observed.

The Company appoints the Company Secretary as the Compliance Officer for the purposes of this Code and the Compliance Officer will be available to Directors/Senior Management Personnel to answer queries / provide clarifications and to help them comply with the Code.

Definitions

"Act" means the Securities and Exchange Board of India Act, 1992.

"Board" means the Directors on the Board of Directors of the Company.

"Code" or "Code of Conduct" shall mean the code of Internal Procedure and Conduct for Regulating, Monitoring and Reporting of trading by insiders of Indo Rama Synthetics (India) Limited as amended from time to time.

"Company" means Indo Rama Synthetics (India) Limited.

"Key Managerial Personnel" means KMP, viz.; Managing Director, Chief Executive Officer (CEO), Whole-time Director, Company Secretary, Chief Financial Officer (CFO), as defined in Section 2(51) the Companies Act, 2013, as amended from time to time.



"Regulations" shall mean SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (hereinafter referred to as "SEBI LODR, 2015) and including any amendments thereto.

In the Code, words importing the masculine shall include feminine and word importing singular shall include the plural or vice versa.

APPLICABILITY

This Code of Conduct applies to the following:

- (i) All Members of the Board of Directors of the Company, whether Independent or Non-Independent or whether Executive or Non-Executive Directors;
- (ii) The Key Managerial Personnel (KMP) as per the Companies Act, 2013, viz.; Managing Director, Chief Executive (CEO), Whole-time Director, Company Secretary, Chief Financial Officer (CFO);
- (iii) The Senior Management Personnel, i.e., excluding Board of Directors, KMP and including those personnel of the Company, who are members of its core management team and also includes all members management one level below the Executive Directors, KMP including all functional heads; and
- (iv) This code may, from time to time be extended to other senior officers of the Company, as the Board may think fit.

This Code of Conduct is applicable with immediate effect.

THE CODE

1) Accountability:

The Directors/Senior Management Personnel shall discharge their duties in good faith and integrity in business judgment and in the best interests of the Company and its stakeholders. They are expected to use their best endeavours and organize the resources for advancing the Company's objectives. They shall act ethically, honestly, diligently and in good faith to protect the Company's properties, brand equity and image. They shall act in good faith, responsibly, with due care, competence and diligence and without allowing their independent judgment to be subordinated. They shall act in the best interests of the Company and fulfil their fiduciary obligations.



2) Conflict of Interest:

The Directors/Senior Management Personnel shall not engage in any business, relationship or activity, which may be in conflict with the interests of the Company. Notwithstanding anything contain herein, an Independent / Non- Executive Director shall have the full liberty to pursue his/ her independent professional/ business/ employment activities and/ or to assume office(s) of director/ trustee.

Conflicts can arise in many situations. It is not possible to cover every possible conflict situation and at times, it will not be easy to distinguish between proper and improper activity. Set forth are some of the common circumstances that may lead to a conflict of interest, actual or potential:-

- a) They should not engage in any activity/employment that interferes with the performance or responsibility to the Company or is otherwise in conflict with or prejudicial to the Company.
- b) They and their immediate families should generally refrain from investments in such companies/ entities whereby their responsibility to the Company is compromised.
- c) They should avoid conducting Company business with a relative or with a firm/company in which a relative/related party is associated in any significant role.

If such related party transaction is unavoidable, it must be fully disclosed to the board of the Company.

Transactions/ dealing done on arm's length basis shall not be considered to be conflict of interest.

1) Compliance:

All applicable laws, rules and regulations shall be complied with. In order to assist the Company in promoting lawful and ethical behaviour, any possible violation of laws, rules, regulations or the code of conduct shall be reported to the Board of Directors through the Company Secretary.

2) Other Directorships:

The Directors must disclose their Directorship, Committee membership on the Board of other companies and substantial shareholding in other companies to the Board on an ongoing basis.

3) Confidentiality of Information:

The confidential information, including commercial secrets, technologies, advertising and sales promotion plans, unpublished price sensitive information or any information



concerning the Company's business, performance, its customers, suppliers, etc., which is not in the public domain and to which the Directors/Senior Management personnel have access, must be considered confidential and held in confidence, unless authorized to do so and when disclosure is required under any law. No Director/Senior Management Personnel shall provide any information either formally or informally, to the press or any other publicity media, unless specially authorized by the Chairman of the Board.

4) Insider Trading:

The Director/Senior Management personnel shall not derive benefit or assist others to derive benefit by giving investment advice based on unpublished price sensitive information (defined in SEBI (Prohibition of Insider Trading) Regulations, 2015) about the Company and therefore constituting insider information. All Directors/Senior Management Personnel shall comply with SEBI (Prohibition of Insider Trading) Regulations, 2015 and insider trading policy of the Company.

5) Equity:

All attempts should be made to maintain equity and fair justice while dealing on behalf of the Company. The Directors/Senior Management personnel shall be committed to provide a work environment free from unlawful discrimination, harassment and intimidations of any nature. Any kind of harassment and discrimination based on gender, religion, age, sex, national origin and other such characteristics shall be strictly prohibited.

They shall strive for maintaining a safe workplace by following safety and health rules and practices.

6) Consumer/ Investor Focus:

The Directors/Senior Management Personnel shall focus on customer/ investor satisfaction. They shall ensure that the communications given are accurate and truthful and do not deliberately omit important facts or shall not be of misleading nature.

7) Team work and Spirit:

The principles of mutual trust, teamwork and spirit shall be appreciated and maintained. Best efforts shall be made to contribute to an environment that builds confidence and empowers people through personal and professional growth. They shall attempt that the teams grow together through collaborative working, skills development, knowledge sharing and learning from each other. Employees being invaluable assets shall be motivated to achieve higher goals.

8) Corporate Opportunity:

Except as approved by the Board, the Directors/Senior Management personnel are prohibited from:



- a) taking any personal opportunities directly or indirectly that belong to the Company or are discovered through the use of Company's property, information or position; and
- b) using the Company's property, information or position for personal gain/advantage or to cause detriment to the Company.

Notwithstanding anything contain herein, an Independent / Non- Executive Director shall have the full liberty to pursue his/ her independent professional/ business/ employment activities and/ or to assume office(s) of director/ trustee.

9) Gift & Donations:

No Director/Senior Management Personnel of the Company shall receive or offer, directly or indirectly, any gifts, donations, remuneration, hospitality, illegal payments and comparable benefits which are intended to obtain business favours. Subject to this clause, nominal gifts of commemorative nature, for special events/ achievements or in the course of social relations and normal business courtesies may be accepted/ given.

10) Safeguarding Company's Assets:

The use of Company's assets for illegal or non-ethical business purposes shall be strictly prohibited. Protecting the Company's assets regardless of whether the same is tangible or intangible is the responsibility of each Director/Senior Management Personnel.

11) Financial Record keeping and reporting:

It is critical to ensure that all transactions are properly identified, analysed and recorded. Regardless of whether a Director/Senior Management Personnel is directly involved in financial reporting or accounting, most come into contact with financial transactions directly or indirectly. All reasonable efforts are expected to ensure that all business records and reports are accurate, complete and reliable.

12) Duties of Directors:

Without limiting the generality of the duties stated in the Companies Act, 2013, the Listing Regulations, SEBI (Prohibition of Insider Trading) Regulations, 2015 and the Code of Conduct for Prevention of Insider Trading framed thereunder and other applicable laws, the duties of a director are as under:

In terms of Section 166 of the Companies Act, 2013, a Director shall:

- act in accordance with the articles of the Company;
- act in good faith in order to promote the objects of the Company for the benefit of its members as a whole, and in the best interests of the Company, its employees, the shareholders, the community and for the protection of environment;



- exercise his duties with due and reasonable care, skill and diligence and shall exercise independent judgment;
- not involve in a situation in which he may have a direct or indirect interest that conflicts, or possibly may conflict, with the interest of the Company;
- not achieve or attempt to achieve any undue gain or advantage either to himself or to his relatives, partners, or associates and if such director is found guilty of making any undue gain, he shall be liable to pay an amount equal to that gain to the Company;
- shall not assign his office and any assignment so made shall be void.

Further in terms of Para III (Duties) of Schedule IV of Companies Act, 2013, the Independent Directors shall:

- undertake appropriate induction and regularly update and refresh their skills, knowledge and familiarity with the Company;
- seek appropriate clarification or amplification of information and, where necessary, take and follow appropriate professional advice and opinion of outside experts at the expense of the Company;
- strive to attend all meetings of the Board of Directors and of the Board Committees of in which he is a member;
- participate constructively and actively in the committees of the Board in which they are chairpersons or members;
- strive to attend the general meetings of the Company;
- where they have concerns about the running of the Company or a proposed action, ensure that these are addressed by the Board and, to the extent that they are not resolved, insist that their concerns are recorded in the minutes of the Board meeting;
- keep themselves well informed about the Company and the external environment in which it operates;
- not to unfairly obstruct the functioning of an otherwise proper Board or Committee of the Board:
- pay sufficient attention and ensure that adequate deliberations are held before approving related party transactions and assure themselves that the same are in the interest of the Company;
- ascertain and ensure that the Company has an adequate and functional vigil mechanism and to ensure that the interests of a person who uses such mechanism are not prejudicially affected on account of such use;
- report concerns about unethical behaviour, actual or suspected fraud or violation of the Company's code of conduct or ethics policy;
- acting within his authority, assist in protecting the legitimate interests of the Company, shareholders and its employees;
- not disclose confidential information, including commercial secrets, technologies, advertising and sales promotion plans, unpublished price sensitive information, unless such disclosure is expressly approved by the Board or required by law.



Notwithstanding anything contained in the Companies Act, 2013, an independent director or a non-executive director (not being promoter or key managerial personnel), shall be held liable, only in respect of such acts of omission or commission by the Company which had occurred with his knowledge, attributable through business processes, and with his consent or connivance or where he had not acted diligently.

13) Compliance with the Code:

Once every year or upon revision of this code, every Director/ Senior Management Personnel must acknowledge and execute an understanding of the code and an affirmation that he/she has complied with the Code. New Directors/ Senior Management Personnel will sign such a deed at the time of joining.

14) Amendment/ Modification/ Waiver:

This code may be amended, modified, varied of waived by the Board as may be deemed necessary in the interests of the Company and subject to the provisions of applicable laws, regulations or guidelines. As a general policy, the Board will not grant waiver of this code.

15) Reporting:

While every Director/Senior Management Personnel has to himself ensure compliance with this code, any instance of violation or possible violation of this code by the concerned Director/ Senior Management Personnel or by any other Director/ Senior Management Personnel shall be immediately reported to the Board through the compliance officer.

16) In case of any doubt as to the best course of action, the concerned Director/ Senior Management Personnel should promptly contact the Compliance Officer.

Note: This Policy modified and approved by the meeting of Board of Directors held on 14th February, 2020.

This revised Code of Conduct shall be posted on the website of the Company.
